AUDIT/FINANCE COMMITTEE March 1, 2016 Minutes

OPEN MEETING:

1. Receive a report, hold a discussion, and give staff direction regarding the FY 2014-15 Comprehensive Annual Financial Report and annual audit.

Chuck Springer, Director of Finance, stated that the annual audit process has been completed, and overall we had positive results. Jerry Gaither and Sara Dempsey, with Weaver and Tidwell, LLP, reviewed the results of the annual audit. The auditor's report on the financial statement is an unmodified or "clean" opinion. The City has implemented the GASB 68 requirement that reflects the pension liability on the financial statements. Sara Dempsey, with Weaver and Tidwell, LLP, explained the audit process in depth and how the City of Denton received the final audit opinion. The auditor's report on internal control over financial reporting and on compliance was issued with no material weaknesses. The auditor's report for the single audit (for grant funding in accordance with OMB Circular A-133) was issued with an unmodified or "clean" opinion with no findings noted.
