ABSENT (2): Members Crouch and Parker.


**D. BOC21-008** Receive a report, hold a discussion, and provide information on the updated 2019 Bond Election - Street Improvements planned issuance schedule.

**Public Art Transportation**

- 2012/2014 Bond project balance - \$311,773
- Original plan for medallions on I-35E (Brinker and Lillian Miller)
- Proposed options to PAC – Approved sculptures on Carroll, Dallas/Teasley and Eagle/Elm
- Current planning for I-35E-UNT to I-35N-US77
- **Option 1** – Funding for sculptures on Carroll, Dallas and Bonnie Brae roundabout (added), this would allow us to close the project accounts
- **Option 2** – Delay spending funds and utilize for aesthetics on I35E and I-35N (embossed medallions and beautification)
  - Match with funding from GCAA of \$290,000
  - Total of approximately \$600,000 for highway beautification
  - Anticipated bidding to begin January 2025
