MINUTES CITY OF DENTON ECONOMIC DEVELOPMENT PARTNERSHIP BOARD March 9, 2016

After determining that a quorum was present, the Economic Development Partnership Board convened on Wednesday, March 9, 2016 at 11:20 a.m. The meeting was held at the Denton Chamber of Commerce, 414 W. Parkway, Denton, Texas, 76201.

1. WORK SESSION

A. <u>EDP 16-009</u> Receive a report, hold a discussion, and give staff direction regarding a proposed manufacturing project by Samuel, Son & Co., Limited, to be located in the West Park TIRZ.

Booth presented background information and explained that Samuel offers end-to-end solutions in the distribution, transportation, processing, and manufacturing of metals and industrial products. Booth explained that the manufacturing process does not include smelting, only processing (machine cutting) of metal coils. McCoy asked for an example of their product. Booth gave an example of components used to build the nacelle portion of wind turbines. Bissett added that G.E. is one of Samuel's largest contracts.

The company is considering a 175,000 square foot facility on a 20-acre rail-served site at the southeast corner of Western Boulevard and Jim Christal Road. The project would be located in the Westpark TIRZ. Booth mentioned that Denton is competing with Alliance and that Samuel will present its relocation options to its corporate board in April 2016, with anticipation of a first quarter opening of their new facility in 2017.

B. <u>EDP 16-015</u> Receive a report, hold a discussion and give staff direction regarding an economic development incentive for Sally Beauty Company, Inc.

Booth gave a history of the company, mentioning that Sally Beauty has been based in Denton since 1982, at that time Sally had 119 stores. Currently they have over 5,000 stores world-wide. They have approximately 1,000 full time employees and they are in the top seven private employers in the City. Booth also mentioned that Sally will be transferring 200 employees from their acquisitions of other companies and plan to add an additional 80 employees in the next two years. They are a good community citizen, as they support several local charitable organizations. Their current project includes a complete interior remodel of the building located at 3900 Morse Street.

- A. <u>EDP16-013</u> Consider approval of the minutes of the February 10, 2016, meeting Breedlove motioned to approve the minutes as presented. Fykes seconded the motion. The minutes were approved unanimously with a vote of 8-0.
- B. <u>EDP16-010</u> Consider a recommendation to the Denton City Council regarding an economic development incentive for a proposed manufacturing project by Samuel, Son, & Co. Limited, to be located in the Westpark TIRZ.

Breedlove motioned to recommend approval to the Denton City Council regarding an economic development incentive of 50 percent abatement for ten years for a manufacturing project by Samuel, Son & Co., Limited. Fykes seconded. The motion was approved unanimously with a vote of 8-0.

C. <u>EDP 16-014</u> Consider a recommendation to the Denton City Council regarding an economic development incentive for Sally Beauty Company, Inc.

Rivers motioned to approve a 50 percent abatement for three years. Costa seconded the motion. The motion was approved unanimously with a vote of 8-0.

2. CONCLUDING ITEMS

A. Updates from staff

- **1.** Booth mentioned the Convention Center Groundbreaking event, which is scheduled for Monday, March 21.
- **2.** Gawarecki gave an update on Recruitment Day. He and the EDP Staff hosted local Site Selectors for lunch and a tour of Denton. Thirty Site Selectors were invited, and eight Site Selectors participated in the event.
- **3.** Glover mentioned that the City, the Chamber, CVB, UNT, and TWU will have a collaborative booth at the SXSW interative trade show.
