  - b. Organization: Denton County MHMR; Presenters: Kollin Weaver and Emma Schultz

During deliberation of the applications, Member Cheek reported a conflict of interest on the item, recused herself from the deliberations.

**Member Courts moved to recommend Our Daily Bread for full funding (\$100,000) for Rapid Rehousing. Member Lester seconded the motion. The motion carried.**
