ID 21-2182 Consider a motion to reconsider the September 28, 2021 approval of an ordinance of the City of Denton, Texas, regarding a change in the zoning district and use classification from Mixed-Use Neighborhood (MN) and Residential 4 (R4) Districts to Mixed-Use Neighborhood (MN) District on approximately 0.326 acres of land generally located southeast of the intersection of Robertson Street and Skinner Street, in the City of Denton, Denton County, Texas. (Z21-0005d, 418 Robertson Fourplex, Tina Firgens).
