- 4. Although it is recognized that existing districts may be altered to reflect population distribution, any redistricting plan should, to the extent possible, be based on existing district;
- Amend to include the following: [Underline added for clarity on added language.]
 - 6. Districts should be compact and composed of contiguous territory. Compactness may contain a functional, as well as a geographical, dimension <u>and preference for decreasing indentedness.</u>

Motion seconded by Council Member Beck. Motion failed.

• The plan should be narrowly tailored to avoid racial gerrymandering in violation of Shaw v. Reno and to avoid age-based gerrymandering in violation of the 26th amendment to the US Constitution.
