ITEMS FOR CONSIDERATION

A. CSAC21-016 Consider approval of the minutes of November 12, 2021.

B. CSAC21-017 Receive a report, hold a discussion, and give staff direction regarding applicant presentations for the American Rescue Plan (ARP) Behavioral Healthcare Services Grant and Nonprofit Capacity Support Grant applications.

Committee received presentations from the American Rescue Plan (ARP) Behavioral Healthcare Services Grant applicants.

C. CSAC21-018 Consider approval of funding recommendations to City Council for the American Rescue Plan (ARP) Behavioral Healthcare Services Grant and the Nonprofit Capacity Support Grant applicants.

The item was presented, discussion followed, and gave direction for funding applications.

The committee recommended funding for all Nonprofit Capacity Support Grant applicants at requested amounts totaling \$430,556. Committee recommended unrequested funding in the Nonprofit Capacity Support Grant of \$119,444 be awarded to Our Daily Bread in lieu of funding through the Behavioral Healthcare Services Grant.

The committee recommended funding Children's Advocacy Center for North Texas, Inc., North Texas Solutions for Recovery, Inc., and Denton County MHMR Center at their requested amounts

totaling \$739,821. Committee members also recommended funding Cumberland Presbyterian Children's Home at a reduced amount of \$155,179, meeting the total funding award for the Behavioral Healthcare Services Grant of \$895,000.

Member Wright moved to approve the Behavioral Healthcare Services Grant and the Nonprofit Capacity Support Grant funding recommendations. Member Lester seconded the motion. The motion carried.
