






Roadway Project Development Process









Project Overview


Project Scope:

 Construction for this project will provide multiple areas of improvement including wastewater, water utility upgrades, road restoration, and reconstruction.

Project Extents:

- E. Hickory(Exposition to S. Ruddell)
- · E. Oak (Bradshaw to S. Wood)
- N. Wood (Paisley to McKinney)
- S. Wood (Mckinney to Sycamore)
- · Bradshaw (McKinney to E. Hickory)
- E. McKinney (Crawford to Audra)
- · Uland (Rose to Railroad)
- · Rose (Paisley to Uland)
- Hettie (Paisley to McKinney)





Project Schedule and Budget

Schedule:

- · Contract time will begin on March 7th, 2022
- The project is expected to be substantially completed within 330 calendar days from start of contract

Completion timeline is weather dependent

Budget:

· Cost for this project is \$7.2 million



What to Expect During Construction

- Access to homes in active construction areas
 - Contractor will work with residents for driveway access and safe routes in and out of the neighborhood during construction

- Road closures and detours
 - Prior notice to residents of upcoming temporary street closures
 - Clear detour route signage will be posted during closures

- · Temporary water outages
- IMPRO the event of temporary water outages during construction, the Contractor will provide advance notice to impacted residents
