A. FP22-0030: Consider a request by Kimley-Horn for approval of a Final Plat for Summerwell Denton, IIB. The approximately 14.434-acre site is generally located 1280.2 feet west of Mayhill Road, approximately 2000 feet south of Spencer Road in the City of Denton, Denton County, Texas. (FP22-0030, Summerwell Denton, IIB, Angie Manglaris).

The approximately 17.05-acre site is generally located at the southwest corner of the I-35 Southbound Service Road and Barthold Road in the City of Denton, Denton County, Texas. The approximately 0.793-acre subject site is generally located just north of Panhandle Street and approximately 165 feet west of Bonnie Brae Street in the City of Denton, Denton County, Texas. (ZCP22-0033, Dr. Dooley Medical Office, Mia Hines)

The 10.579-acre site is generally located just west of IH-35 and approximately 2,100 feet South of West University Drive (US-380) in the City of Denton, Denton County, Texas. (PP22-0023, Blue Horseshoe Addition, Mia Hines).

The 568.029-acre site is generally located just north of West University Drive and south of Jackson Road just east of Nail Road in the City of Denton's ETJ Division 1, Denton County, Texas. (PP22-0017b, Legends Ranch, Mia Hines).

4. PUBLIC HEARING

A. AESA22-0001a: Hold a public hearing and consider making a recommendation to the City Council regarding a request by Alex Camunez of Pacheco Koch for an Alternative Environmentally Sensitive Areas Plan. 380 Logistics Warehouse Buildings is a site generally located on the northeast side of the intersection of US Highway 380 and Geesling Road in the City of Denton, Denton County, Texas. THIS ITEM HAS BEEN WITHDRAWN. (AESA22-0001a, 380 Logistics Warehouse Buildings, Christi Upton)

B. Z22-0003: Hold a public hearing and consider making a recommendation to City Council regarding a request by 97 Land Company on behalf of the Mason L Ralph Trust to change the zoning of 2.604 acres of land from Suburban Corridor (SC) District to Mixed-Use Neighborhood (MN) District and 0.196 acres of land from Residential-3 (R3) District to Mixed-Use Neighborhood (MN) District. The subject properties are generally located north of East University Drive between Nottingham Drive and Old North Road in the City of Denton, Denton County, Texas. (Z22-0003, 380 Multifamily SC to MN, Mia Hines)

Chair Ellis opened the public hearing.

Staff and the Applicants, Aimee Bisset and Matt Swedenburg, presented the item and a discussion followed.
