1. Work Session Reports

A. ID 22-1823 Receive a report and hold a discussion regarding an update on the Denton Housing Strategy.

And

B. Receive a report and hold a discussion regarding City of Denton and Denton Housing Authority housing priorities.

The items were presented and discussion followed.

Following discussion, there was no direction provided as the item was for presentation/discussion purposes. Key components were identified in addition to those presented:

Cerember 6, 2022

- Develop housing strategy task force;
- Collaboration on establishing a housing trust incentive program (clearinghouse);
- Low income ownership program;
- Educating landlords about the housing voucher program;
- Location and site of a development (neighboring assets, assurance that financial markets are underwriting deals, unit size/affordability, safety measures, vicinity/access to schools);
- Low income tax credit program;
- Real estate and construction costs obstacles;
- Housing for seniors;
- Increase funding for the housing voucher programs;
- Bring down cost of development which in turn will affect affordability;
- Developers who have affordable housing and are willing to accept housing vouchers reach out to DHA; and
- City will provide a list of properties that may be available for potential affordable housing opportunities.
- C. ID 22-1550 Receive a report, hold a discussion, and give staff direction regarding topics for future joint meeting discussions and updates.

The item was presented and discussion followed.

Following discussion, there was no direction provided as the item was for presentation/discussion purposes. The following were identified as areas to address:

- Holding joint meetings with/between the City, Denton Housing Authority, University of North Texas, Texas Woman's University, Denton Independent School District, hospitals, to talk about rehousing, property owners, current and future developers to address the need for affordable housing strategies.
- DHA will review City's request to consider recording their meetings and report back; City will consult with its DTV staff on potential meeting options available.
- DHA representative possibly present update(s) to City Council at a scheduled meeting.
