May 16, 2023

After determining that a quorum was present, the City Council of the City of Denton, Texas convened in a Special Called Meeting on Tuesday, May 16, 2023, at 12:31 p.m. in the Council Chambers at City Hall, 215 E. McKinney Street, Denton, Texas.

Mayor Pro Tem Beck nominated himself. Council Member McGee seconded the nomination.


Mayor Hudspeth called a voice vote on the motion to elect Council Member Beck as Mayor Pro Tem.
