### 3. CONSENT AGENDA

A. Consider a request by Aimee Bissett on behalf of Tealstone Residential Concrete for approval of a Preliminary Plat of the Tealstone Addition. The approximately 6.58-acre site is generally located at the northeast corner of Cooper Creek Drive and Mingo Road, south of Fishtrap Road, in the City of Denton, Denton County, Texas. (PP18-0022, Tealstone Addition, Sean Jacobson).

B. Consider a request by PACCAR Inc. for approval of a Final Plat for Lot 10R, Block A, Westpark Addition. The approximately 12.065-acre site is generally located on the west side of Precision Drive, approximately 330 feet south of West Oak Street in the City of Denton, Denton County, Texas. (FP18-0035, Peterbilt Plan, Hayley Zagurski).

### 4. PUBLIC HEARINGS

A. Hold a public hearing and consider a request by Aimee Bissett with NorthBridge Consultants representing the property owner Bret Andrus for approval of a Final Replat of the Rancho Vista Addition, being a non-residential replat of Lot 6, Block 1. The applicant is requesting to replat the property into two lots with the intent of developing each lot with a commercial use. The approximately 1.14 acre property is generally located on the north side of Emery Street, approximately 800 feet east of Bonnie Brae Street, in the City of Denton, Denton County, Texas. (FR19-0002, Rancho Vista Lot 6 Split, Ron Menguita)

Ron Menguita, Principal Planner, presented Public Hearing item 4A. Menguita stated the request is to replat the property into two lots for a commercial use. Menguita continued to state staff does recommend approval of the request.

B. Hold a public hearing and consider a request by John Cox with Eagle Surveying, LLC representing the property owner Brad Andrus for approval of a Final Replat of the Crescent Brae Addition, being a non-residential replat of Lot 1, Block A. The applicant is requesting to replat the property into two lots with the intent of developing each lot with a commercial use. The approximately 0.74 acre property is generally located on the northeast corner of Bonnie Brae Street and Crescent Street, in the City of Denton, Denton County, Texas. (FR19-0004, Crescent Brae Addition, Ron Menguita)

Chair Rozell opened the Public Hearing.

Ron Menguita, Principal Planner, presented Public Hearing item 4B. Menguita stated the request is to replat the property into two lots for a commercial use. Menguita continued to state staff does recommend approval of the request.

Hold a public hearing and consider making a recommendation to City Council regarding a proposed revision to the Denton Development Code; specifically to amend Subchapter 5 Zoning Districts and Limitations, Subchapter 8, Group Homes, Subchapter 14, Parking Standards, and Subchapter 23, Definitions related to supportive residential uses and treatment facilities. (DCA19-0004, Treatment Centers, Julie Wyatt).

Commissioner Tim Smith motioned, Commissioner Margie Ellis seconded to postpone Public Hearing item 4C to the April 17, 2019 Planning and Zoning Commission meeting. Motion approved (6-0).
