Consensus of the Commission was to update Section 17-402.2 due to recent Federal rulings from: Every common hall and stairway in residential occupancies, other than in one-and two-family dwellings, shall be lighted at all times with not less than a **60-watt incandescent light bulb or 9 LED Watts** for each 200 square feet (19 m2) of floor area or equivalent illumination, provided that the spacing between lights shall not be greater than 30 feet (9144 mm). to Every common hall and stairway in residential occupancies, other than in one-and two-family dwellings, shall be lighted at all times with not less than a **800 Lumens light bulb** for each 200 square feet (19 m2) of floor area or equivalent illumination, provided that the spacing between a stairway in residential occupancies, other than in one-and two-family dwellings, shall be lighted at all times with not less than a **800 Lumens light bulb** for each 200 square feet (19 m2) of floor area or equivalent illumination, provided that the spacing between lights shall not be greater than 30 feet (9144 mm).

Discussion continued.

Commissioner Mollen to table the discussion regarding section 17-602.3.2 to the next meeting. Motion seconded by Vice-Chair Stevens. Motion carried.
