Minutes Planning and Zoning Commission April 10, 2019

After determining that a quorum was present, the Planning and Zoning Commission of the City of Denton, Texas convened in a Work Session on Wednesday, April 10, 2019 4:00 p.m. in the Council Work Session Room at City Hall, 215 E. McKinney Street, Denton, Texas at which the following items were considered:

1. Carification of agenda items listed on the agenda for this meeting. Commissioner Pruneda stated there are a lot of people that are concerned about duplexes and triplexes that are possible with the new zoning, but as mentioned they are not allowed by right and neighboring properties will be notified of the request.

Commissioner Beck questioned if an applicant has already submitted the final plat for a final phase will they be obligated to submit under the new Denton Development Code. Richard Cannone, Deputy Director of Development Services, stated if the plat is already in process then it would be under the existing code.

Ron Menguita, Principal Planner, addressed the comment regarding the legal non-conforming building. Menguita stated staff has defined non-conforming which is in Subchapter One.

McDonald continued to state with that being said, staff does not anticipate the draft zoning map being adopted. McDonald continued the public hearing will be opened, than receive feedback from steak holders, citizens, property owners and those concerned with the changes.

McDonald stated the map will be postponed to an indefinite date, but will be heard again within 45 to 60 days so staff is able to find any inconstancy in the map, address public concerns, and then include those in a City initiated rezoning.

McDonald continued to state when this goes forward staff will being working with legal staff to ensure the process used will be constant with the local government code.
