





Project Details

This project will:

- Project will move public utilities in supporting the I-35 widening with the relocation of 10,200 linear feet of water/wastewater utilities
- This project is scheduled for 180 days of construction and is estimated to be completed April-May 2024 (weather permitting)
- This is a forced relocation of City of Denton utilities, there will be reimbursements from TxDOT to support this effort at 100%.



What to Expect

CONSTRUCTION PHASE

- Construction will begin October 2023 in various locations (weather permitting)
- All major road crossing will be bored under to reduce traffic delays and closures
- Contractor will coordinate with business owners to maintain a utility disruption schedule
- Pedestrian detour routes are anticipated
- Message Boards will be updated with anticipated changes
- Goal: Minimum of 48-hour notice before utility disruption at residences and businesses
- Reality: Some unscheduled utility disruption MAY occur during the construction and will be considered top priority for resolution. If your utility service is disrupted unscheduled, contact the City of Denton or Contractor team immediately

WHAT ARE THE CONTRACTORS WORKING HOURS?

When will the contractor start work in the morning – when will they stop?

- Standard working hours are Monday through Friday 7am to 4pm (Per City Contract available working hours are 7am to 8pm)
- Weekend Work MAY Occur if warranted and per the City's contract

 (Weekend Working Hours—Those hours between 8:00 a.m. and 8:30 p.m. on Saturday, and between 1:00 p.m. and 8:30 p.m. on Sunday or on a federal or state holiday observed by the City, as approved in advance by the City for performing Work.)

WHEN IS THE PROJECT GOING TO BE FINISHED?

The project is anticipated to be substantially completed by April 2024. (weather permitting) The goal is to provide a minimum of 48-hour notice for utility disruptions.
