## Joe Skiles Park Information

Joe Skiles Park is a 5.78-acre neighborhood park located within the Southridge subdivision:

#### **Park Amenities**

- Furnishings: Picnic tables, benches, drinking fountain, grill
- Pavilion (capacity 18 people)
- Basketball court with 3 goals
- Playground (5-12 play structure)
- (Two) Tennis Courts
- Multipurpose field w/Soccer Goals

### Park land was dedicated to the City of Denton in June 1964

• Federal Land and Water Conservation Grant received in 1970's for park improvements

### In the last 5 years

- Basketball & Tennis Court resurfaced in 2020.
- 5-12 playground structure replaced in 2021.

### **During this fiscal year**

- City Council allocated funding from the American Rescue Plan Act (ARPA) to be used for various park projects throughout the City. (\$3.4M)
  - Joe Skiles Park, Denia Park, Carl Young Sr. Splashpad Phase 2, Trail projects


#### Toddler area

# **Final Plans**

- •Addition of Loop Trail
- Irrigation Installation
- •Re-grade multi-purpose field
- •Trees Planted Estimated 40
- •Shade over existing playground and addition of 2-5 play structure
- •Addition of new pavilion accommodate 50 people
- Enhanced fencing around tennis court
- •Lights to be phased, but conduit will be installed for future connection. When funding is appropriated.



# **Construction Impacts & Schedule**

### Work Conducted to-date:

- Tree Removal:
  - The reasons for removal can vary, including potential safety hazards, damage from cold weather, disease or decay.
    - Crape Myrtles 6
    - Sweetgum Trees 1
- Concrete Bench removal along Stonegate Dr.

### **Other Impacts & Schedule:**

- Portion or entire park may be closed during construction and implementation of master plan.
- Communication on closures to occur in Discuss Denton
  - Chain-link fence to be strategically placed throughout park to protect patrons and workers
- Anticipate starting construction mid-October
- Completion of Park estimated to conclude April-May 2024



45 trees estimated to be planted.


 Species: Mexican Sycamore, Autumn Blaze Maple, Cedar Elm, Chinese Pistache, Monterrey Oak



# **ADA Accessibility**

## Neighborhood Park Standard:

- Typically, do not require or provide parking lots.
  - Exception:
    - When renovated, accommodations must be provided. I.E: ADA Parking Stall, ADA ramps
    - If receiving federal funding: ADA accessibility infrastructure (ADA ramps, handicaps to be installed.



The City of Denton Parks and Recreation Department owns a 5.78-acre developed parcel named Joe Skiles Park, located at Stonegate Dr., Denton, TX 76205. The park features a recently installed playground, two tennis courts, three half basketball courts, a multi-purpose field, benches, picnic tables, and a small pavilion. City Council adopted the Parks, Recreation, and Trails System Master Plan on March 1, 2022. The Master Plan provides an analysis of various parks, (includes Joe Skiles) and gives the department guidance in addressing short and long-term goals as funding allows. This agreement is vital in future planning for Parks and Recreation and its mission to serve and meet the community's needs.

The scope of the project improvements will consist of public engagement, design, and construction. The items currently identified as improvements include but are not limited to the following: Loop trail to increase access and connectivity, irrigation to improve turf quality, benches, and landscaping improvements.

Parks and Recreation will schedule public meetings later this spring. Updates and information relating to the project will be updated below. Please subscribe within the icon on the top right of this page to be notified when new updates are uploaded.
