BOARD OF ETHICS MEETING MINUTES July 22, 2019

After determining that a quorum of the Board was present, the Board of Ethics of the City of Denton, Texas convened on Wednesday, July 22, 2019 at 5:30 p.m. in the City Hall Conference Room at City Hall, 215 E. McKinney Street, Denton, Texas.

Chair of the Board Tomlin opened the meeting at 5:30 PM

ITEMS FOR CONSIDERATION:

A. Consider approval of the minutes of July 10, 2019.

Motion made to approve the minutes of July 10, 2019.

B. Receive a report, hold a discussion, and give staff direction regarding an update from the July 16, 2019 City Council Work session presentation and discuss additional amendments to the Ethics Ordinance and take possible action.

Chair Tomlin gave a report on the July 16, 2019 City Council Work Session where she presented the Board of Ethics recommendations to the City Council for Ethics Code changes. Discussion followed on how to proceed with more specific recommendations. Motion made to send City Council members specific recommendations on several amendments to the Ethics Ordinance representing those unanimously agreed on by the

Board. The motion also included the directive to staff to set another meeting for August 29th to further discuss recommendations.

C. Receive a report, hold a discussion, and give staff direction regarding the scheduling of regular Board of Ethics Meetings.

The Board had unanimous agreement to schedule regular meetings the last Thursday of each month.

D. Receive a report, hold a discussion, and give staff direction regarding an update on the Board of Ethics meetings audio file posting.

City Auditor Umesh Dalal informed the Board that the audio files of all prior meetings have now been linked to the Board of Ethics webpage.

E. Address preliminary matters related to hearing and take necessary action.

Chair Tomlin asked Complainant and Accused if they had any preliminary matters to discuss. Board Member McDaniels and Vice-Chair Zoltner recused. No preliminary matters were given.

F. Consider and take possible action on Ethics Complaint No. 19-003, found to be actionable 3/27/19 by a Panel of the Board of Ethics, concerning alleged violations of Ethics Ordinance Sections 2-272 and 273. This Hearing is being conducted under the authority of Ethics Ordinance Section 2-281 (c).

Complainant and Accused presented evidence and arguments regarding the alleged violation. Chair Tomlin called a recess at 7:08 pm and Board reconvened at 7:20 pm. Board Members deliberated in open session on the evidence and arguments submitted. Members were then asked for a Violation or No Violation vote by Chair Tomlin:
