2. ITEMS FOR CONSIDERATION

A. Consider approval of the meeting minutes of February 6, 2020.

Lynn made a motion to approve the minutes of February 6, 2020. Bagherpour seconded the motion. Motion carried (6-0).

B. Receive a report, hold a discussion, and give staff direction regarding a partnership with Keep Denton Beautiful, Inc. to recreate the Foundation of Our History mural previously considered for donation by the Hudspeth family.

Rogers presented the item. Rogers stated that the PAC had already committed \$4,500 towards the project, but the total project cost was \$11,500. Currently, Keep Denton Beautiful had commitments for \$6,850.70, but still needed \$3,149.30.

Committee members requested staff follow up on possibly adding lighting to the bridge so that the mural can be seen at night and using QR codes on the bridge to link to information about the women represented on the mural.

Bagherpour made a motion to approve funding for the project in the amount of \$7,649.30, including the \$4,500 already committed and the \$3,149.30 needed to fully fund the project, from the PAC's HOT funds. Lynn seconded the motion. Motion carried (6-0).
