1. ITEMS FOR CONSIDERATION

A. <u>BOE20-005</u> Consider approval of the minutes for February 13, 2020.

Don Cartwright made a motion to accept the meeting minutes of February 13, 2020. Rob Rayner seconded the motion. The motion carried unanimously (7-0).

B. <u>BOE20-008</u> Hold a discussion on updates to the current membership of the Board of Ethics.
