1. CONSENT AGENDA

- **A.** <u>PUB20-111</u> Consider recommending adoption of an ordinance of the City of Denton, a Texas homerule municipal corporation, authorizing the City Manager, or his designee, to execute approval documents under the Joint Operating Agreement of the Texas Municipal Power Agency ("TMPA") among and between the Texas Municipal Power Agency, City of Bryan, Texas, Denton, Texas, the City of Garland, Texas and the City of Greenville, Texas, regarding the TMPA budget for the fiscal year 2021; providing for the expenditure of funds therefore; and providing an effective date.
- **B.** <u>PUB20-115</u> Consider recommending adoption of an ordinance of the City of Denton, a Texas homerule municipal corporation, authorizing the City Manager to execute a contract with Prime Controls, LP, for the Think and DO Conversion project at the Ray Roberts Water Treatment Plant; providing for the expenditure of funds therefor; and providing an effective date (RFP 7369 awarded to Prime Controls, LP, in the not-to-exceed amount of \$135,000).
- C. <u>PUB20-116</u> Consider recommending adoption of an ordinance authorizing the City Manager, or his designee, to execute amendment No. 2. between the City of Denton, a Texas municipal home-rule corporation, and the Texas Municipal Power Agency ("TMPA") that extends the term of the existing agreement by two years to September 1, 2022; authorizing the expenditure of funds; and providing an effective date.
- **D.** <u>PUB20-119</u> Consider recommending adoption of an ordinance of the City of Denton, a Texas homerule municipal corporation, authorizing the City Manager to execute a contract with vendors for the rental of heavy construction equipment for various City Of Denton Departments; providing for the expenditure of funds therefor; and providing an effective date (RFP 7295 awarded to Kirby-Smith Machinery, Inc., Bane Machinery, Inc., United Rentals (North America), Inc., Romco Equipment Co., LLC, RDO Equipment Co., Sunbelt Rentals, Inc., Herc Rentals, Inc., Associated Supply Company, Inc., dba Asco Equipment, Inc, Closner Equipment Co., Inc., Holt Texas, Ltd., and DCMM Rental One, Ltd. dba Rental

One Equipment, for three (3) years, with the option for two (2) additional one (1) year extensions, in the total five (5) year not-to-exceed amount of \$1,500,000).

Board Member Bafford pulled item A.

Board Member C. Parker motioned to approve items B, C and D with a second by Board Member Russell. Vote 6-0.

Terry Naulty was available to answer questions for item A. Bafford stated there are no cost shown after 2024 and had some questions. Naulty answered that all the capital items should be completed by 2024 and went on to explain further. There were further questions by other Board Members.

Board Member Bafford motioned to approve item A with a second by Board Member Cheek. Vote 6-0.
