After determining that a quorum of the Committee on Persons with Disabilities was present, the Committee of the City of Denton, Texas convened in a meeting via video/teleconference on Thursday, July 16, 2020 at 1:00 p.m. in the City Council Work Session room at 215 E. McKinney Street, Denton, Texas.

1. PRESENTATIONS FROM MEMBERS OF THE PUBLIC

2. ITEMS FOR CONSIDERATION

A. CPD20-013 Consider the approval of the meeting minutes of February 20, 2020.

Rex King motioned for approval and Alison Kelly seconded to approve the draft minutes as presented for the February 20, 2020 meeting. The motion carried unanimously.

B. CPD20-014 Receive a report, hold a discussion and give staff direction regarding the allowable uses of the Downtown Reinvestment Grant Program and the possible addition of funding Americans with Disabilities Act (“ADA”) improvements on eligible projects.

Director of Economic Development gave a presentation and a discussion followed. The Committee is in favor of the described provision of the grant.

C. CPD20-015 Receive a report, hold a discussion and give staff direction regarding an update of the All-walk Crosswalk pilot program at the downtown intersections at Oak and Elm, Oak and Locust, Hickory and Elm, and Hickory and Locust.

Brian Jahn, City Traffic Engineer gave a presentation and summary of the public input on the program.

Following the discussion, the Committee is in favor to continue the program and the plan to complete the associated sidewalk reconstruction plans to include the diagonal crossing pattern, tactile features and timing review. The education and enforcement process will be continuing. The program will be re-labeled as All-Way Crossing.

Considering the current public conditions, activity is also being considered to reduce the touch points to activate the signal changes with equipment scheduled to be tested in other parts of the City.

- D. CPD20-016 Receive a report, hold a discussion, and give staff direction regarding the 2020 Denton Mobility Plan Update, with a focus on the one-way vs two-way traffic analysis.

Brian Jahn shared a presentation and a discussion was held. The consensus from the committee is that one-way streets are the preferred option.

- E. CPD20-018 Staff Report

Mario Canizares announced this would be his last meeting as he will be terminating his employment with the City of Denton.





## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, City of Denton (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. For such copies, as long as you are an authorized user of the DocuSign system you will have the ability to download and print any documents we send to you through your DocuSign user account for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

### **Consequences of changing your mind**
