REGULAR MEETING

A. MC20-018 Consider the approval of the meeting minutes of February 11, 2020.

CM Ryan made a motion to approve. CM Briggs seconded the motion.
 CM Ryan voted for approval.
 CM Briggs voted for approval.
 CM Meltzer voted for approval.
 The minutes were approved by vote (3-0).

B. MC20-019 Receive a report and hold a discussion regarding updates from the Denton County Transportation Authority (DCTA).

Nicole Recker spoke about staff and service changes due to the impact of COVID-19.

Questions were asked and answered. A report on the grant for the expansion of the A-Train and transit-oriented development project will be provided by DCTA in follow-up.

D. MC20-021 Receive a report, hold a discussion and receive direction regarding future Mobility Committee meeting schedule dates and times.

The item was presented, and a discussion followed.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Denton (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. For such copies, as long as you are an authorized user of the DocuSign system you will have the ability to download and print any documents we send to you through your DocuSign user account for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. Consequences of changing your mind
