CITY OF DENTON COMMITTEE ON PERSONS WITH DISABILITIES MINUTES September 17, 2020

After determining that a quorum of the Committee on Persons with Disabilities was present, the Committee of the City of Denton, Texas convened in a meeting via video/teleconference on Thursday, September 17, 2020 at 3:00 p.m. in the City Council Work Session room at 215 E. McKinney Street, Denton, Texas.

1. PRESENTATIONS FROM MEMBERS OF THE PUBLIC

Resident Ms. Sherry Anderson, 8485 Jim Crystal Road called in to share her support of the Take Me Home program. She is a mother of an adult autistic son. She spoke about her experiences in the past when she moved to Denton with her son and her early interactions with her neighbors. She has been in touch with Chief Dixon who has shared some of the concerns he has received.

- a. The perception this will make more encounter with the Police. She does not feel or understand why that is a bad thing. The Police Officers are well trained. and if children are raised to respect authority and taught that police are not bad, this should not be an issue at all.
- b. Who signs a person up for this program? This is done by the legal guardian. It was voiced that this person would not have a choice to be signed up for this program. It is your responsibility as a parent or guardian to protect that child and this is a way of protecting them.
- c. How do you know it is not an abusive home they are being returned to? You don't. However, the Police are very trained and have programs to ensure that is not happening through their investigations and involvement just like they do with any other person being returned to a home. They do this all the time for Alzheimer's, dementia and multiple different conditions where that needs to be addressed.

As a parent, we are now looking at a program that was implemented by the Texas Department of Public Safety. On the driver's license, if an autistic person is pulled over the officer will know the person may have communication that might be altered. This program is very similar to the Take Me Home Program and one can voice their opinion if they want to participate in the drivers' program. The Take Me Home Program is for

younger kids and older adults that can't make those decisions. She strongly supports this program and will encourage parents of autistic children and applicable family members that this can bring peace and comfort to them.

A total of eleven (11) virtual white comment cards received and distributed to the committee members in advance of this meeting along with one (1) email sent to Chief Dixon. They are attached here for the record as part of the meeting minutes.

B. CPD20-020 Receive a report, hold a discussion and give staff direction regarding the Take Me Home Program offered by the Denton Police Department.

Chief Dixon of the Denton Police Department gave a presentation and a discussion followed. Questions were asked and addressed. An invitation will be extended in the future for interaction and input from the members with the Police Department.

C. CPD20-021 Receive a report, hold a discussion and give staff direction regarding accessibility in the Development Services Building, remodeled Police Headquarters, and Police Substation.

Scott Gray, Director of Facilities and CIP Facilities gave a presentation and addressed comments from the committee.

D. CPD20-022 Receive a report, hold a discussion, and give staff direction regarding considerations for the recruitment and hiring of an ADA

Coordinator/Transportation Planner.

Brian Jahn shared a presentation and asked for the committees input on the elements of the skill set were most important. The job description is currently being developed and this new person will become an active participant in this committee.

An appreciation for the combination of the transportation and ADA coordinator was expressed.

A request was made to have the Chair from this committee and perhaps another committee within the City that has a similar interest or related focus to review the applications or even sit in on the interviews. This request will be forwarded on to management staff.

With the consideration for this newly created position, is the City not looking to hiring an overall ADA Coordinator? The current policy that has been adopted by Council is divided to cover the three primary areas. Staff cannot make changes to this policy without the approval or direction by City Council. The question was asked if this committee could make a recommendation to Council to have a single ADA Coordinator for the City. It was confirmed and was asked if Staff would like to see this brought forward for discussion as part of the concluding items.

Strong interests were expressed to prioritize the background, experience and certifications in the consideration for the candidate selection.

An interest in looking outside the box for someone who represents their community for this candidate. There are disabled people who have the certifications, background and the education. The questions where we look for these people. Consider adding a preferred qualification personal experience with a disability is placed on the description then determining where it is published or distributed. The request was to begin having representation from the community this committee represents and that the City serves.
